



Approach

- Continue to implement POM10-15 Intent & Guidance
- Accept/make minimal changes to program (Change Proposals)
- Address issues that cannot wait for POM12-17
- Zero-sum

- Version of PB10 submitted to Congress; fiscal guidance
- Army-directed Change Proposals
- Timeline for submission
- Early QDR recommendations

Expected OSD PBR 11-15 Guidance

- Focus on FY11
- President's Budget FY10 forms the baseline for FY11-15 Program Budget Review – No POM
- Minimize programmatic changes
- Submit Change Proposals (CPs) to request baseline changes to OSD PA&E
 - Facts of Life (FOL) adjustments (FY11)
 - Programmatic resource offsets to FOL adjustments no increase to Army TOA
 - Limit number of other issues
- Submit Budget Estimate Submission reflecting change proposals to OUSD(C)

- 2. PBR 11-15 Fiscal Guidance
- 3. Timeline for submission (s)

PB 10 / PBR11-15 Known Army Issues

- Address Force Structure and Army Endstrength challenges

Command Briefs

PBR11-15 Commander's Narrative Assessments

- The purpose of the Commander's Narrative Assessment (CNA) is to give each Army Command, Army Service Component Command, Direct Reporting Unit /Agency or Army-serviced Combatant Command commander the opportunity to provide a personal assessment of the command's program, to include the command's issues and concerns.
- Responsible Agency for CNAs is the Office of the Deputy Chief of Staff, G-8, Program Analysis and Evaluation Directorate (PAED)
- PBR11-15 Guidance:
 - The Commander's Narrative should be no more than 3-5 pages in length, and
 - Provide the commander's personal assessment of the command program as it is resourced in the Appropriation File 1.2 of POM/BES FY2010-2015.
 - Identify up to three significant shortfalls in meeting the goals of the Army Campaign Plan (ACP) for FY2011; propose internal offsets to address the shortfall; and demonstrate why the requested change should be considered by senior Army leadership.
- When developing assessments and preparing for PBR11-15, commands must consider that the Army expects fiscal guidance to remain constant (best case) or be significantly reduced (worst case) from POM10-15 levels. Any reductions will be applied across the Army program impacting all commands and any proposed enhancements/adjustments.
- Command/Agencies will submit its CNA to HQDA not later than 15 March 2009
